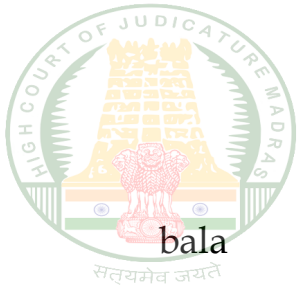
The writ petition is listed today under the caption 'for reporting compliance'.
