5.With the above observations, this Writ Petition is disposed of.

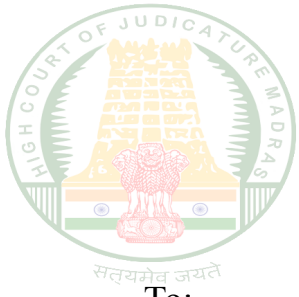
