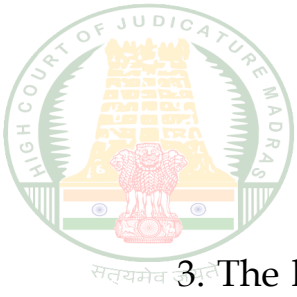
PETITION FOR RELAXATION Under Sec.528 of BNSS.
