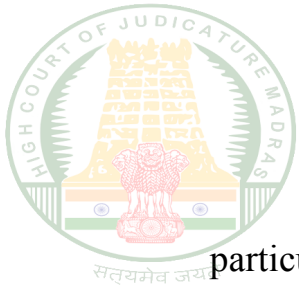

The writ on hand has been instituted to forbear the respondents from constructing any building for the office of the fourth respondent in S.No.71, situate at Thondi First Class Town Panchayat without extending the same for the purposes of Government Hospital, Thondi by considering the petitioner's representation dated 22.04.2025.

2. The petitioner, as an individual, cannot have any option or a right to suggest that the Government building must be constructed in a
