2.Heard the arguments of M/s.P.Subha Rani, learned counsel appearing for the petitioner, Mr.M.Gangatharan, learned Additional Government Pleader appearing for the respondents 1 to 3 and Mr.M.Vaikkam Karunanithi, learned Government Advocate appearing for the respondents 4 to 6. By consent of both sides, this Writ Petition is taken up for final disposal at the admission stage itself.

3.It is the case of the petitioner that the above said property, with an extent of 1.89 acres, was purchased by the petitioner and two others under a registered sale deed dated 06.02.2023. Thereafter, the petitioner submitted an online application on 03.06.2025, seeking survey of the said land purchased by him. The petitioner has also paid necessary survey charges. However, the application of the petitioner has not been considered. Hence, he has come before this Court.

4.The learned Government Advocate appearing for the respondents 1 to 3 would submit that the petitioner made an application only on 03.06.2025 and the same will be considered in due course on its own merits.
