Prayer in CRL OP(MD)No.5217 OF 2025:-

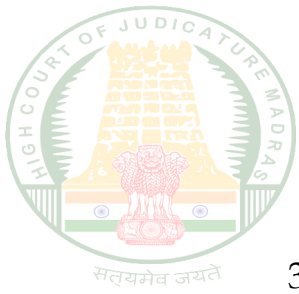
