The learned Government Advocate and the learned Additional Government Pleader appearing for the respondents have produced a copy of the communication received from the tender inviting authority, wherein it is stated that the petitioner failed to furnish the requisite documents along with the bid submitted on 30.05.2025. Therefore, the petitioner's bid was rejected during the initial stage of scrutiny.
