3.The time is extended by fifteen days from today to comply with the order dated 17.04.2025.

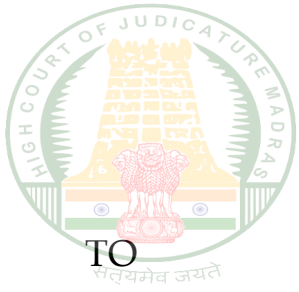
