PRAYER: Writ Petitions filed under Article 226 of the Constitution of India, praying this court to issue a Writ of Mandamus, directing the respondents to pay 18 percent interest amount of Rs.9,51,299.46/- for the belated payment of Terminal Benefits amount of Rs.52,84,997/- from the date of the petitioners retirement i.e. on 30.06.2023 to till the date of actual payment made to the petitioner i.e. 16.04.2025.

ORDER

The present Writ Petition has been filed by a retired Driver of the respondent Transport Corporation, who had attained superannuation on 30.06.2023 seeking a Mandamus for payment of interest for the belated disbursement of terminal benefits.

2. According to the learned counsel appearing for the writ petitioner, though the petitioner had retired from service on 30.06.2023, the terminal benefits were released only on 19.04.2025. Hence, the petitioner has addressed a communication to the respondents on 14.12.2024, seeking payment of interest for the belated disbursement of terminal benefits. Since there is no response, the present writ petition has been filed.
