The petitioner/defacto complainant in Crime No.180 of 2022 has approached this Court that the respondent police has not filed the final report in the above crime number.

2.Mr.P.Kottaichamy, learned Government Advocate (Crl.side) takes notice for the respondents and submits that the investigation in Crime No.180 of 2022 has been completed and they found that no case is made out and therefore, they are going to refer the case as "mistake of fact" and they require some time to serve RCS notice to the petitioner.
