2.Heard the learned counsel appearing on either side and perused the materials placed before this Court.



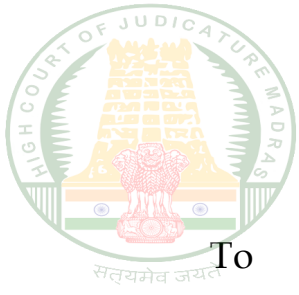

When the Writ Petition is taken up for hearing today, the learned Government Advocate appearing for the respondents 1 to 3 would submit that the request made by the Petitioner was already considered by the Tahsildar, Tirunelveli in his proceedings in Na.Ka.Aa7/2298/2024, dated 9.6.2025 and parties were relegated to work out their remedy before the Wakf Tribunal as a Wakf called, Katta Baba Pallivasal claimed right over the subject property. The learned Government Advocate also produced a copy of the order passed by the Tahsildar, Tirunelveli.

4. In view of the said submission made by the learned Government Advocate appearing for the respondents 1 to 3, the Writ Petition is dismissed, with liberty to the Petitioner to challenge the order passed by the Tahsildar, Tirunelveli in Na.Ka.Aa7/2298/2024, dated 09.06.2025 before the Appellate Authority concerned, namely the Revenue Divisional Officer. No costs.
