4. Post the matter 'for reporting compliance' on 20.08.2025.'

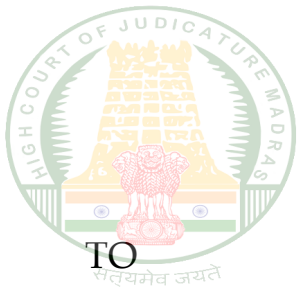
