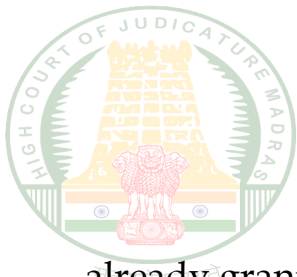
ORDER : The Court made the following order :-

2. Heard the learned counsel for the petitioners and the learned Government Advocate (Criminal Side) appearing for the respondent.

3. Since the order passed by this Court in CrI.O.P.(MD) No.6801 of 2025, dated 17.04.2025, was made ready only on 16.05.2025, the learned Judicial Magistrate No.I, Virudhunagar, is directed to accept the receipt of the payment of Rs.50,000/- (Rupees Fifty Thousand only) deposited on 30.05.2025.

4. Considering the reasons stated in the petition, the time for executing the sureties by the petitioners before the concerned Court is extended by two weeks from the date of receipt of a copy of this order, failing which the anticipatory bail
