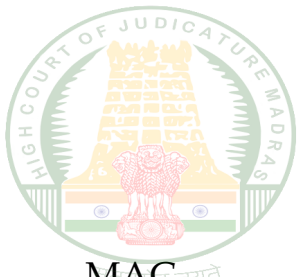
4. Accordingly, this Criminal Miscellaneous Petition is ordered.
