2.Heard the arguments of Mr.M.Gandhirajan, learned counsel appearing for the petitioner, Mr.M.Gangatharan, learned Government Advocate appearing for the respondents 1 to 4 and Mr.M.Vaikkam Karunanithi, learned Government Advocate appearing for the fifth respondent. By consent of both sides, this Writ Petition is taken up for final disposal at the admission stage itself.

3.The petitioner claims right over the above mentioned property under a Settlement Deed dated 15.03.2021. The patta for the subject property stands in the name of the petitioner's father, who settled the property in favour of the petitioner in Patta No.257. The petitioner submitted an online application on 13.05.2025 in Application No. 2025/0123/13/012169, seeking survey of the property. However, the same has not been considered. Hence, the petitioner has come before this Court.

4.The learned Government Advocate appearing for the respondents 1 to 4 would submit that the application of the petitioner will be considered on its own merits within the time stipulated by this Court.
