4. With the above modification, this Criminal Miscellaneous Petition is allowed.

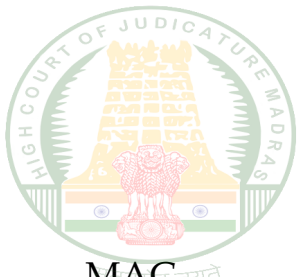
