3. The learned Government Advocate (CrI.Side) submitted that the petitioner has complied with the condition for nearly 19 days.

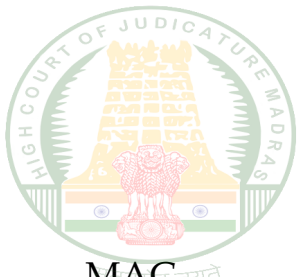
