3. The learned Government Advocate (Crl.Side) submitted that the petitioner has complied with the condition regularly.

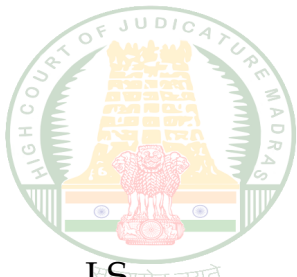
