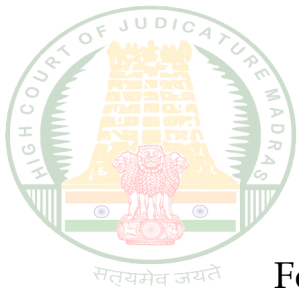

2. Heard the learned counsel on both sides and perused the materials available on record.

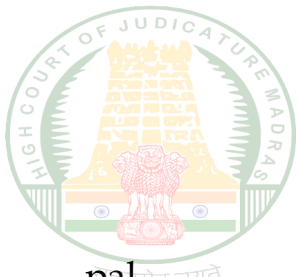
