This petition has been filed for extension of time for compliance of the conditional order passed in Crl.O.P(MD).No.8522 of 2025 dated 08.05.2025.

2. The learned Counsel appearing for the petitioners would submit that the first petitioner was affected from Jaundice, he was taking treatment at Kerala. Due to which, the petitioners are not able to arrange sureties and appear before the concerned Judicial Magistrate Court.
