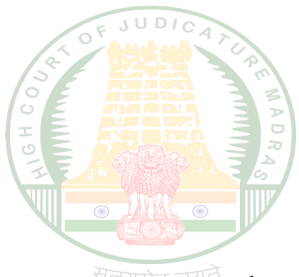

JUDGMENT

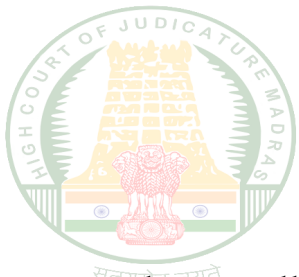
(Judgment of the Court was delivered by S.SRIMATHY, J.)
