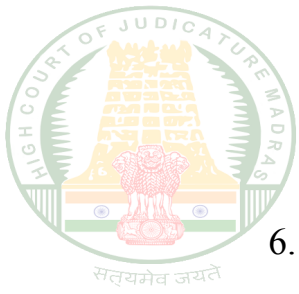

ORDER

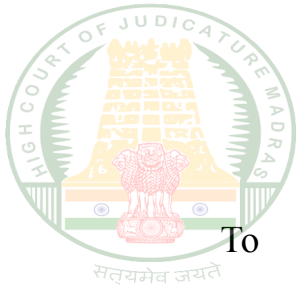
