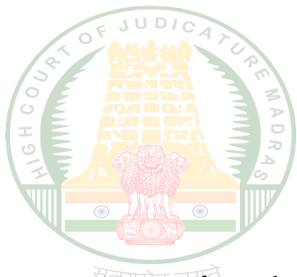

3. The said submissions of the learned Additional Public Prosecutor is recorded and accordingly, no further orders are required in this Habeas Corpus Petition.
