PETITION FOR MODIFICATION Under Section 528 of BNS Act, 2023

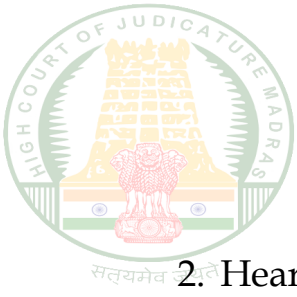
