This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant Mr.N.Shyllappakalyan and the counsel for the respondent Mrs.K.R.Siva Shankari for R4 are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.



AWARD



The Insurance Company has filed the above appeal challenging the award passed by the Tribunal. Now, the parties have arrived at a settlement for a sum of Rs.1,32,919/- (Rupees One Lakh Thirty Two Thousand Nine Hundred and Nineteen only) as full quit. The same is recorded.

2. The appellant / Insurance Company has already deposited a sum of Rs.66,919/- (Rupees Sixty Six Thousand Nine Hundred and Nine only). The appellant is directed to deposit the balance amount of Rs. 66,000/- (Rupees Sixty Six Thousand only) within a period of eight weeks from today.

3. The claimant is entitled to withdraw the award amount by filing appropriate application before the Tribunal.
