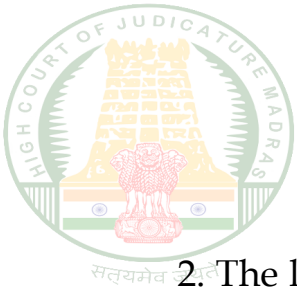
PETITION FOR RELAXATION Under Sec.528 BNSS

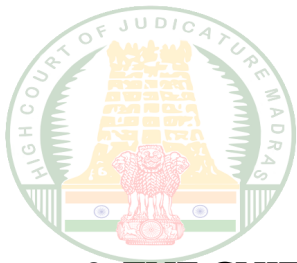
