2. The learned counsel for the petitioner submitted that the petitioner has been complying with the conditions imposed by this court regularly and he prays for relaxation of the said condition.

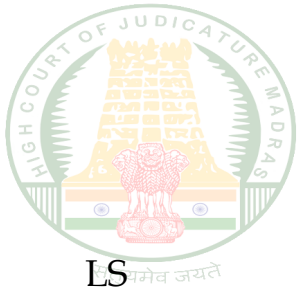
3. The learned Government Advocate (CrI.Side) submitted that the petitioner has complied with the condition for regularly.
