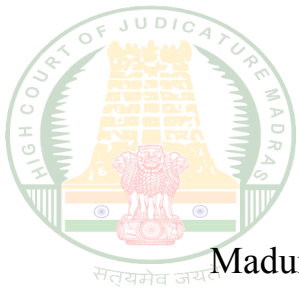

[Order of the Court was made by S.M.SUBRAMANIAM, J.]

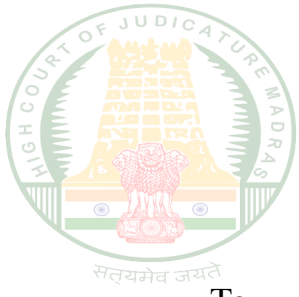
The order passed under Section 6 of Tamil Nadu Land Encroachment Act is under challenge in the present writ proceeding.
