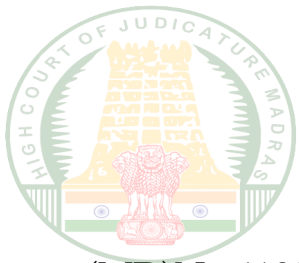

If 1st and 15 day falls on a holiday, the petitioner shall appear before the above said Court on the next working day."
