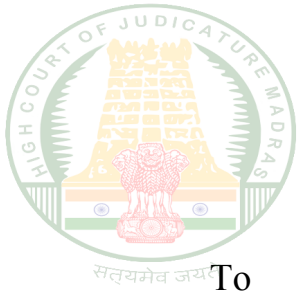
2. The notice to the respondents 1 to 16 is dispensed with in view of the limited order being passed.
