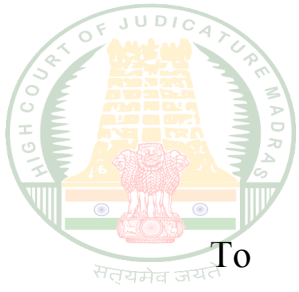
Police, Madurai District, reported in **2020 (2) LW (Crl.) 266**, by considering his representation dated 26.05.2025.
