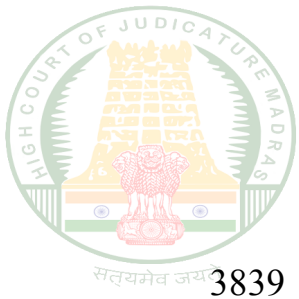
ORDER

In view of the above, without expressing any opinion on the merits of the claim made by the petitioners, the respondents are directed to consider the on-line application dated 07.11.2024 and pass final orders on its own merits within a period of six weeks from the date of receipt of a copy of this order, after issuing notice to the petitioner and neighbouring land owners.
