ORDER

The petitioner herein seeks a direction to the respondents to disburse compensation amount in respect of the property situated in S.F.No. 310/2, Navalpattu Village, Trichy Taluk and District, which was acquired by the respondents, by considering his representation, dated 08.05.2025.

2. According to the petitioner, the subject property belonged to him and the same was acquired by the respondents, without issuing any notice. Hence, he, represented by his Power Agent, submitted a representation before the respondents on 08.05.2025, seeking disbursal of compensation amount in respect of the acquired property. The same has not been considered. Hence, he has come before this Court.

3. The Government Advocate, who takes notice for the respondents, would submit that the representation submitted by the petitioner would be considered on its own merits.
