3. In view of the above, this application stands dismissed.

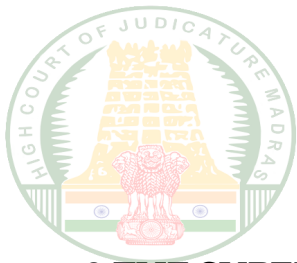
4. Registry is directed to list the matter for final hearing.
