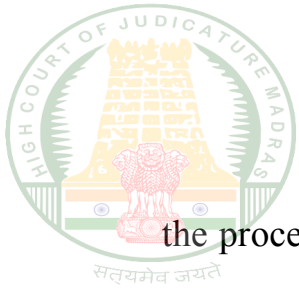
ORDER

Prayer in this writ petition is to direct the respondents 1 & 2 to grant the emergency leave for the period of 15 days without escort to the petitioner's father who is a convict prisoner namely Chandirasekaran, S/o.Karuppaiah (CP No. 8996) who is languishing in Madurai Central Prison.

2. Today, when the matter is taken up for hearing, Mr.A.Thiruvadi Kumar, learned Additional Public Prosecutor, on instructions, submitted that the representation of the petitioner dated 04.06.2025 seeking 15 days emergency leave to his father/ convict has been rejected by the second respondent *vide* proceedings dated 13.06.2025 and to that effect, he has also produced a copy of the proceedings dated 13.06.2025 before this Court.

3. In view of the above submission of the learned Additional Public Prosecutor, this writ petition is closed with liberty to the petitioner to challenge
