2. The learned counsel for the petitioners submitted that the petitioners have been complying with the conditions imposed by this court regularly and he prays for relaxation of the said condition.

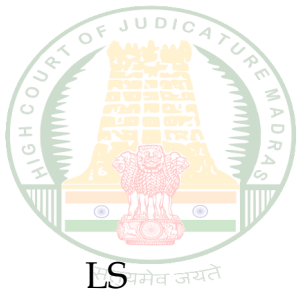
3. The learned Government Advocate (Crl.Side) submitted that the petitioners have complied with the condition for regularly.
