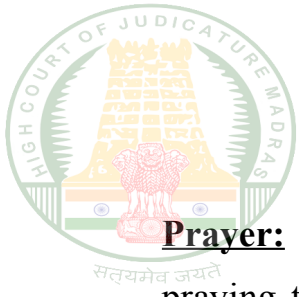

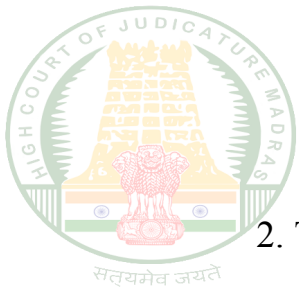

4. Recording the same, the second respondent is directed to dispose of the petitioner's representation, dated 10.08.2024 within a period of four weeks from the date of receipt of a copy of this order.

5. The writ petition stands disposed of with the above direction. No costs. Consequently, the connected miscellaneous petition is closed.
