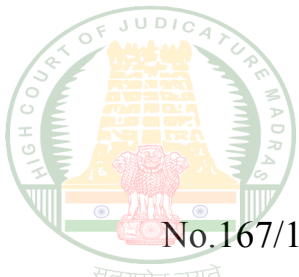

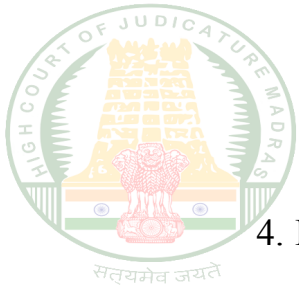

3. The learned Special Government Pleader for the respondents 1 to 3 has filed the report of the Village Administrative Officer, wherein, it has been stated that no road has been laid on the petitioner's patta land in S.No.167/8b.
