6. The learned Advocate General upon instructions would agree that the offer of the 263 employees, who had also signed the offer is acceptable to the University and with reference to re-deployment, the same or equivalent post or a post commensurate with their educational qualification and experience and pay parity.

3. The other part of the order will be sustained.”

3. Though the petitioner herein who was originally appointed as liaisioning officer has now been called upon to discharge his duty as Superintendent, his pay parity has been assured.

4. Recording the undertaking of the respondents, the contempt petition is closed. Consequently, connected miscellaneous petition is closed.
