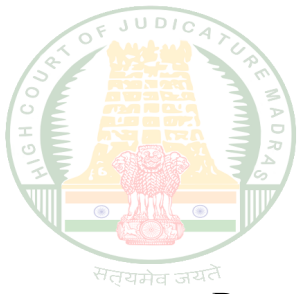

The challenge in this writ petition is to the order rejecting the petitioner's claim for approval of appointment as B.T.Assistant (Science), on the ground that they are awaiting orders from the Secretary to Government and that the request of the petitioner will be considered only after such orders are passed.

2. It is also placed on record that there are no surplus teachers in the petitioner School.

3. This Court is of the view that the surplus teachers in the other schools other than the petitioner's school cannot be taken as a ground to reject the claim of the petitioner.

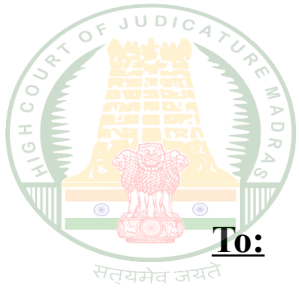

In such view of the matter, the impugned order is set aside and the issue is remitted back to the third respondent to re-consider the case of the petitioner and pass appropriate orders on merits and in accordance with law within a period of 6 weeks from the date of receipt of a copy of this order.
