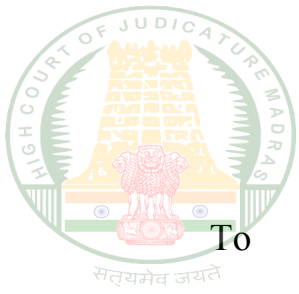
3. With the above observations, the writ petition stands disposed of. No costs. Consequently, connected miscellaneous petitions are closed.
