ORDER

The present Writ Petition has been filed by a retired Driver of the respondent Transport Corporation, seeking disbursement of the surrender leave salary along with interest.

2. Though the petitioner has retired on 31.05.2023, the surrender leave salary has not been disbursed to the writ petitioner, despite giving representation to the respondents on 14.03.2025, for disbursing the said benefits. Since the representation has not been considered, the present Writ Petition has been filed.

3. Heard the learned counsel appearing for the petitioner and the learned Standing Counsel appearing for the respondents.

4. Considering the above said facts, the respondents herein are directed to release the eligible surrender leave salary upon the writ petitioner along with interest at the rate of 6% p.a., from the due date till the date of disbursement, within a period of twelve weeks from the date of receipt of a copy of this order.
