A charge sheet has been filed and the case has been taken on file by the learned Judicial Magistrate, Aruppukottai in C.C.No.206 of 2025. The case has been listed for the appearance of the petitioner on 22.07.2025.

3. Since the offence has already been taken on file, the question of granting any relief to the petitioner at this stage does not arise.
