3. Post the matter on 26.08.2025.'

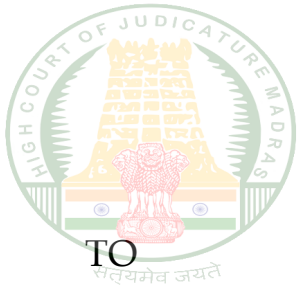
