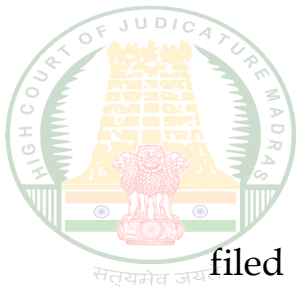
Prayer in WP(MD)No.5479 of 2019 :-
