3.In view of the submission made by the learned counsel for the petitioner, this petition is dismissed.

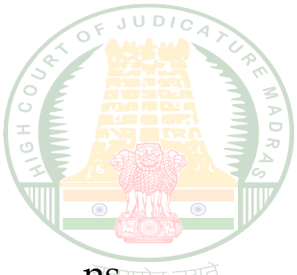
