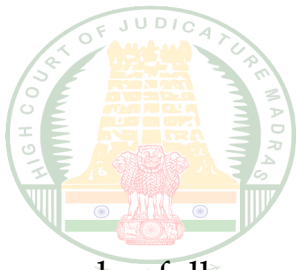
ORDER
