The petitioner has filed this petition with a grievance that his application filed for return of his vehicle bearing Reg No.TN48B 5123 has been returned by the learned Judicial Magistrate, Vendasandur that he is not having any document for ownership.

2. The learned counsel appearing for the petitioner submits that the petitioner has purchased the vehicle bearing Reg.No.TN48B 5123 from one Sakthivel on 09.01.2025. However, this vehicle has been seized by the respondent Police in Crime No.80 of 2025 on 24.02.2025. He further submits that the said Sakthivel has not transferred RC Book in his name.
