2. The petitioner appears to have submitted a representation, dated 28.09.2024 to the respondents for framing a scheme for the management of Abdullha Khan Bailim Pallivasal @ Pudhukulam Pallivasal, Veppankulam Village, Tirunelveli Taluk and Tirunelveli District.

Recording the same, the respondents are directed to consider the petitioner's representation, dated 28.09.2024 and take a decision whether a scheme is required to be framed in the background of proforma, dated 04.07.1956. In case, a scheme is to be framed, issue appropriate notice to all the persons, who are likely to be affected by the proposed exercise. The said exercise shall be completed within a period of 12 weeks from the date of receipt of a copy of this order.
