ORDER

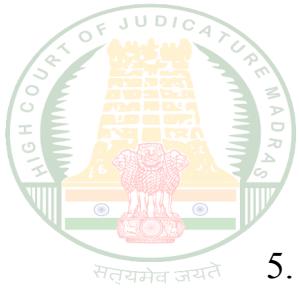

The Writ petition is filed seeking direction to the first respondent to consider the petitioner's application No.2025/0154/34/603791, dated 15.05.2025.

2. The petitioner has submitted a representation before the first respondent, dated 15.05.2025, seeking issuance of separate Patta in his favour based on the sale deed, dated 29.10.2018. The petitioner has also filed an online application on the same date in application No.2025/0154/34/003791 and the same has not been considered. Hence, the petitioner has filed this Writ Petition.

3. The learned Additional Government Pleader appearing on behalf of the first respondent would submit that the application submitted by the petitioner will be considered in accordance with law.

4. The learned counsel for the second respondent would submit that there is a title dispute with regard to the claim made by the petitioner in respect of the subject property. Therefore, objection has raised by the second respondent shall be heard by the first respondent before considering the petitioner's application.
